The Nunavut Water Board (NWB) has scheduled its hearings on the Draft Nunavut Water Regulations (Draft Regulations) in September 2011. The Kitikmeot Inuit Association (KitIA) has prepared a submission to the NWB to outline Inuit concerns related to the Draft Regulations. The submission is attached to this letter.

An Executive Summary of the submission in English is provided with the submission. We will provide the NWB with a translated Executive Summary by September 1, 2011.

The joint submission addresses three issues. They are:

**Reclamation security (Draft Regulations section 10)**

1. Double bonding issue
2. The security matching criteria issue

**Licensing fees (Draft Regulations sections 11 and 12)**

1. The double payment of water use fees on Inuit Owned Land

The Kitikmeot Inuit Association would like to advise the Board that it does not intend to appear at the Board's hearing. If the Board or the parties should need to question the KitIA, we can arrange to participate by teleconference.
