Hello Ms. Beaulieu,

I am writing to you on behalf of the Department of National Defence to advise you that the Department of National Defence is interested in remaining a stakeholder in the consultation process for the renewal of Water Licence 1AR-NAN0914, which expires on March 31, 2014.

In recent discussions with Nyrstar Canada Holdings Inc. (representing CanZinco Ltd.), it was brought to our attention that they had an intention of submitting a Water Licence Renewal application to the Nunavut Water Boardin November. It is also our understanding that this application for renewal would include a proposed change to the previously approved 'Abandonment and Reclamation Plan, Fuel Tank Farm, Former Nanisivik Mine Site, Nunavut' (Jacques Whitford Stantec Ltd., 2010).

In conversation with Mr. Parsons (AANDC, cc'd above), DND understands that part of the Water Licence Application review process may include two public hearings. DND is interested in information regarding the timing and location of these hearings, as we are interested in participating and the possibility of presenting.

I look forward toany feedback you are able to provide with respect to this process and most specifically when documents related to the Water Licence Renewal application will be made available for review on the Nunavut Water Board public registry, as well as the date and location of the public hearings.
