**Subject:** Fisheries and Oceans Canada Comments for the Nunavut Water Board

Final Hearing on the Renewal Application for the Nanisivik Mine Project

Type "A" Water License

On December 15, 2008, Fisheries and Oceans Canada (DFO) received the Nunavut Water Board's Pre-hearing Conference Decision for the renewal and amendment application of Type A Water License for the Nanisivik Mine. Based on the information provided by CanZinco Limited, DFO-Fish Habitat Management did not have any issues related to the closure, reclamation or monitoring plans as it relates to fish and fish habitat, thus, did not provide comments.

However, it has come to DFO's attention that clarification is required in relation to DFO's involvement with the transfer of land ownership where the dock, tank farm and tank farm facility are situated. Fisheries and Oceans Canada is the current landowner of the area noted above. DFO – Real Property Management Branch administers the divestiture of DFO owned lands and has been in discussions with the Department of National Defence (DND) and Breakwater Resources Ltd. (Proponent) regarding the transfer.

On February 2<sup>nd</sup>, 2009, DND sent a letter to the Proponent indicating that they will not accept ownership of the tank farm. In response, DFO will be corresponding with the Proponent requesting the removal of the entire tank farm and its facility as well as the remediation of the soils underneath the tanks. Once the tank farm and its facility have been removed and remediated, DFO will proceed with the transfer of the property to DND. The dock will also be included in the transfer of lands.

DFO requires that the Proponent remove and remediate the entire tank farm and its facility as part of the closure and reclamation phase of the Nanisivik Mine Site.
