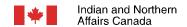

## **Technical Review Memorandum**

The 2009 Comprehensive Contingency Plan Report submitted by Breakwater Resources Ltd. (Bob Carreau) did not contain part "c" of Item 8 under Part I of the Water License. Part "c" of Item 8 under Part I of the Water License is contained in a separate report.

The Comprehensive Contingency Plan addressed many of the requirements of the Water License # 1AR – NAN0914, Part I, Item 8. However, it was noted that the following information was not provided in the 2009 Comprehensive Contingency Plan Report.

<u>Part I Item 8 (a)</u> of the water license states that the Comprehensive Contingency Plan must include a consolidation of contingency measures as provided in the Appendices to the 2004 Reclamation Plan and Closure Plan(s)

The Comprehensive Contingency Plan did not include a consolidation of all contingency measures as provided in the Appendices to the 2004 Reclamation Plan and Closure Plan(s)

If some or all of the contingency measures as provided in the Appendices to the 2004 Reclamation Plan and Closure Plan(s) do not apply to the Comprehensive Contingency Plan then it should be stated, otherwise all contingency measures should be included in the Report.

Breakwater Resources Ltd. should provide the Nunavut Water Board all outstanding information referred to above in order to comply with the requirements of Part I Item 8 parts "a, b and d" of the water license.
