The Nunavut Water Board (NWB) issued, on July 31, 1997, licence NWB1NAN9702 (renewal of N5L3-0159) allowing CanZinco Ltd., Nanisivik Mine (formerly Nanisivik Mines Ltd.) the industrial water use and waste disposal associated with mining, milling and associated uses at the Nanisivik Mine. Shortly afterwards (14/11/1997), the NWB agreed to issue SNP Amendment 01, substituting two sampling and flow monitoring requirements. The NWB subsequently issued, on December 9, 1999 Amendment No. 1 thus allowing for open pit operations at Ocean View. On March 20, 2000 Amendment No. 2 as issued allowing for exploration drilling. The said licence was schedule to expire on June 30, 2002. On December 7, 2001 the NWB issued an extension to licence NWB1NAN9702, extending the expiry date to September 30, 2002. This report assesses compliance with the licence from January 1, 2002 to August 14, 2002 inclusive.

Non compliance in that tailings spills on April 11, 2002 and wind blown tailings on May 2002 resulted in tailings being deposited outside disposal area.

- Non compliance in that water sampled from Twin Creek indicate that Arsenic, Cadmium, Copper Lead and Zinc levels are in excess of licence maximum concentrations.

11. The Licencee shall submit by February 1, 1997 a plan for future modifications to the disposal area.

12. The elevation of the dykes shall only exceed present elevation with written approval of the NWB.

Compliance by licencee having announced closure on October 31, 2001; the due date for Abandonment and Restoration Plan was December 31, 2001. On December 7, 2001 the NWB extended the deadline to February 28, 2002 which the Licencee met.

#### Conclusion

In the year 2002, the Licencee was mostly in compliance with the terms of t heir water licence NWB1NAN9702. Non-compliance issues are noted for Items B-2, Item B-5, D-1, D-2, D-4, E-4 and G-12.

The major outstanding non-compliance issues is the lack of Nanisivik Mine to provide security bond as required in Item B - 2.

Problems were noted by the Inspector in the year 2001 and it appears that samples are not collected at the appropriate time and/or parameters were not measured as required to maximize the efficiency of treatment. Nanisivik Mine has had difficulty in meeting there compliance requirements with regards to discharges at East Adit Treatment Facility and samples taken during this inspection indicate that values in excess of the maximum allowable by licence may be discharged from EATF.

The unauthorised discharge of wastewater from Ocean View Open Pit to abandon underground operations of Nanisivik Mine without authorisation from the NWB in direct contravention of Item D Part 13.

Several sampling requirements of the Surveillance Network Program (SNP) were not made or collected. Nanisivik Mine has failed to provide SNP data for the months of May, June and July.

Some of these outstanding issues may be resolved prior to the end of this operational year. This report is being prepared prior to the completion of this year.
