Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* the Board hereby grants the following licence amendment.

1. **Part D** shall be amended to include the follows:
  13. **Item** The Licensee shall ensure runoff is diverted away from the temporary storage pad and open pit.
  14. **Item** All accumulated pit water is to be directed to a sump and hauled to the East Adit Treatment Plant prior to final discharge.
2. The “**Surveillance Network Program**” shall be amended to include:

**Station 159-18** Runoff at Ocean View Open Pit  
**Station 159-19** Pit water at Ocean View Open Pit

**Sampling Requirements:** Twice during periods of flow

**Analysis Requirements:** Total Lead      Total Cadmium  
Total Zinc      Total Ammonia  
Suspended Solids

pH, Temperature, Specific Conductivity at the time of sampling
