

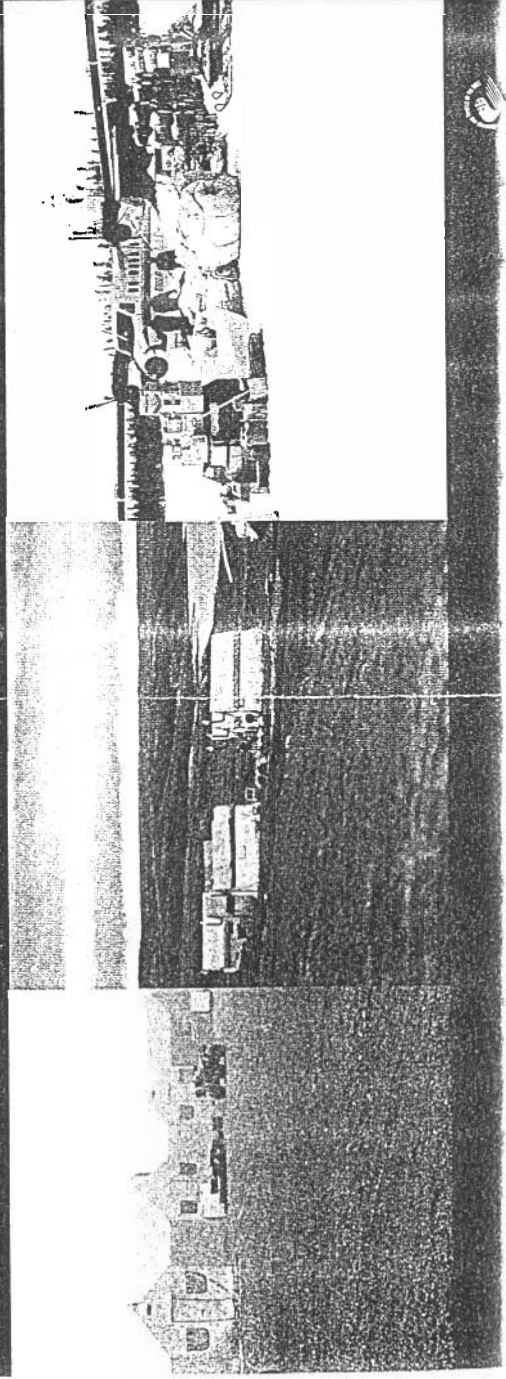

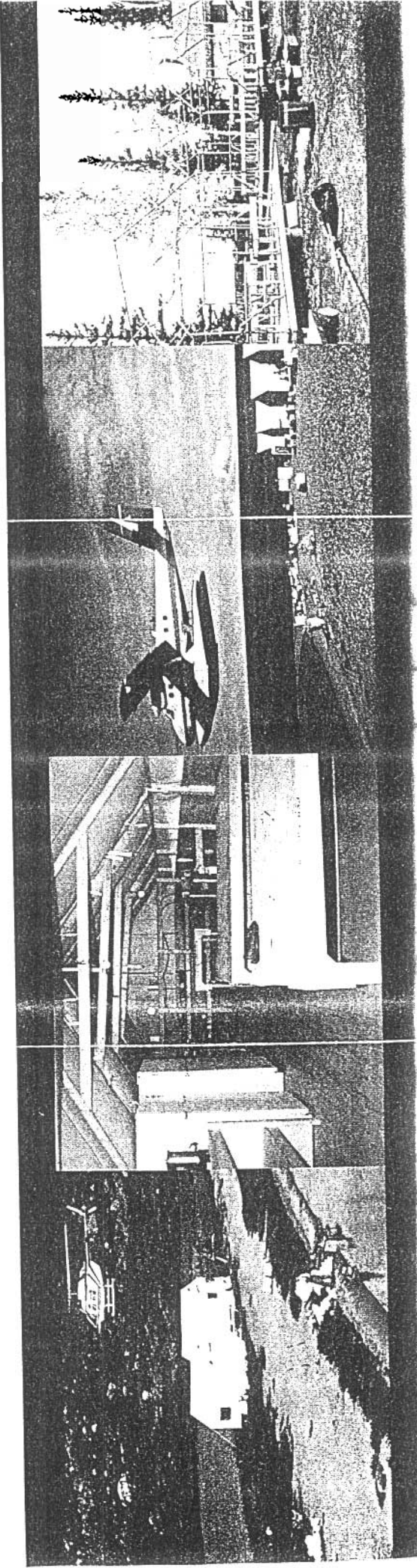

NWT unemployment rate climbs to 9.1% in June

The NWT unemployment rate rose to 9.1% in June (versus 6.7% Canada-wide).

There were 20,900 people employed in the NWT, 500 more than in May, however the number of unemployed also rose by 200, to 2100, because the total number of people looking for work that month increased by 700, to 23,000.

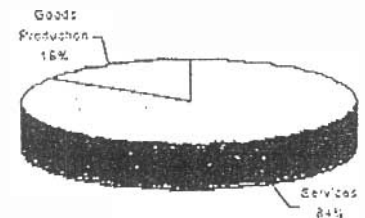
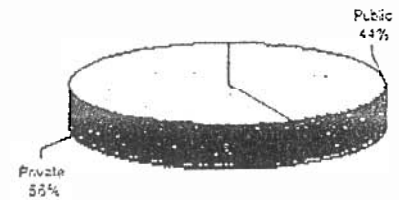
The fact that the number of both employed and unemployed rose in June partly reflects increased student participation in the labour force and increased seasonal activity, such as construction.

The NWT's 70.4% employment rate (i.e. the ratio of employed to population 15 and over) was second only to Alberta's 70.7% among the provinces and other territories.

However, the official territorial unemployment rate was about the same as in Nova Scotia and New Brunswick, and much lower than in the Yukon (about 14%) and Newfoundland (almost 16%).

Employment rates were highest in Yellowknife, and among those males and those over 24 years old.





Crosbie Shipping Limited has relied on its own ice-classed vessels and various other chartered vessels to complete projects and cargo deliveries of a variety of different natures. We list here some of our more significant accomplishments:-

1. In 1981 thru 2000 our company has been servicing Nanisivik Mines Limited with its Canadian sourced sealift cargoes and at times with some of its European sourced requirements.
2. In 1982 thru to 1994 C.A. Crosbie Shipping Limited was the exclusive carrier of Canadian sourced cargo to Cominco's Polaris Mine site on Little Cornwallis Island.
3. Our company was the sole carrier employed by Panarctic Oils Limited when carrying out oil research projects at Melville Island sites from 1981 – 1985.
4. Laval Fortin Limited, a construction company for Defence Construction used our services for the Long Range North Warning Radar Site at Brevoort Island, N.W.T. Using our transportation services (1986 & 1987 sealift seasons) allowed them to complete their undertaking on time and on budget.
5. The work our company completed for P.C.L. constructors who were contracted to build the Short Range Radar Sites at various Baffin Island location (1989 – 1992 sealift seasons) included landing equipment and cargo at these remote and "virgin" sites.
6. Falconbridge (1990 – 1991) employed our company to move in cargo, equipment and trailers for explorations at Douglas Harbour for their Raglan site. We hauled out not only the equipment but also the ore samples that were a result of their researches.
7. Nunasi Inc. (1996 to present) a native company in the Arctic employed our vessel to haul equipment, trailers and fuel to the Cape Hooper site where they are presently effecting a clean up operation.
8. Suncor (1995 – 1996) arranged with us to call into Freeman's Cove in the High Arctic to remove cargo left over from their clean up of this site following the conclusions of the oil research program.

9. Pratt & Whitney (1991) hired our vessel to transport cargo and equipment including a generator and transformer to Goose Bay, Labrador for a prototype gas turbine station being set up in the community. We note that our vessel was the first to arrive in the community that season due to heavy ice.
10. Defence Construction (1986 – 1987) employed our vessel for late season and early season deliveries to Saglek and Cartwright in Labrador.
11. The Black Angel Mine (1982 – 1987) used our services for both late season and early season deliveries of supplies and equipment at various time.
12. The Hibernia Project (1992 – 1995) out of Bull Arm, Newfoundland selected our company to carry all 110,000 tonnes of rebar from Canadian suppliers.
13. The Canadian Coast Guard (1981 to present) has employed our company's services regularly to a wide variety of remote Canadian Arctic destinations as well as Thule, Greenland for the awarded Government Sealift resupply operation.
14. C.A. Crosbie Shipping Limited has also been employed internationally to coordinate and deliveries cargoes to various locations. On a project basis we note two of our special accomplishments in this field:
 1. Our vessel was employed for four seasons in Antarctica by the Governments of France and Australia resupply and personnel to their remote bases.

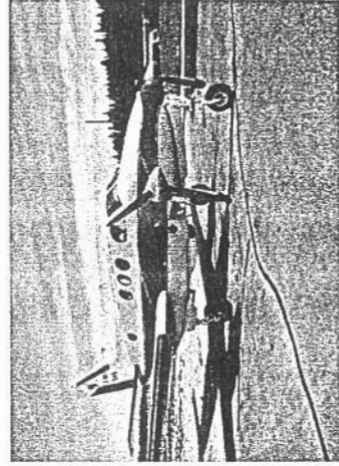
