In reviewing the notice from the NWB on timelines for the submission of documents for the Polaris Public Hearing, AANDC notices that there is only a week to prepare the presentation after seeing TECK's response to our comments due on Nov 7th.

To recap - Licensee report due on Oct 17;

- Intervener response due on Nov 7;

- Licensee response to intervener due on Nov 14;

- Intervener presentation submission due Nov 21 - Only Seven days after seeing the response from Teck (Nov 14).

AANDC would like to have time to review TECK's november 14 response to interveners comments and construct its presentation based on the latest information. Due to internal approvals and translation requirements a one-week turn around is problematic and AANDC is, therefore, requesting an extension of the due date for the presentation from November 21, 2014 to **November 26, 2014**.
