Re: Security Posted by Teck Cominco for Water Licence 1AR-POL0311

Dear Kevin,

I am writing regarding water licence 1AR-POL0311 (Licence). Further to the Nunavut Water Board's (NWB or Board) request for comments issued on April 24, 2009, the NWB has reviewed the Licence and the related application to reduce security pursuant to the Licence. The Licence states under Part B, Item 2:

The Licensee shall post and maintain security in the amount of \$33.7 million in the form required by the Minister of Indian and Northern Affairs Canada, to be paid in accordance with the following schedule:

- a. Within 90 days of issuance of the license a total amount of \$3.7 million;
- b. Subject to Part B, Item 3 and 4, a total amount of \$18 million due December 31, 2003; and
- c. Subject to Part B, Item 3 and 4, a total amount of \$12 million due December 31, 2004.

The NWB has on record an irrevocable letter of credit (ILoC) from the BMO for \$2.7 million, expiring on July 22, 2004, and an additional ILoC for \$14.7 million, expiring on December 22, 2004 for a total of \$17 million. The Board understands that these ILoC's are renewable on a yearly basis unless otherwise notified by the institution; however, the NWB does not have a record of confirmation of these extensions. Furthermore, the NWB does not have a record of further security held by the Indian and Northern Affairs Canada (INAC) in accordance with the Licence requirement for security in the amount of \$33.7 million. Moreover, it appears from the documentation accompanying the application for a reduction in security currently before the Board that the amount current held by INAC is \$18.0 million.
