Hi Cory –

We are working with CGS to determine whether there are any other permits associated with this file. Normally, hydrostatic testing on its own would be exempt from NIRB's screening, however the actual building of fuel tanks of this capacity would not be. We are trying to ascertain whether the tanks have been built yet, and if not, whether further permitting may be associated with this file in particular.

I have a line in with the new municipal engineer at CGS in the Kivalliq, and hope that she can provide more information this week. If we don't hear anything back before then, we will proceed with a 12-1 exemption next week.
