RE: Spill Contingency Plan Approval for Licence 1BH-RFS0910 Part H Item 1, Type "B"

Dear Mr. Losier:

The Nunavut Water Board ("NWB") received on January 12, 2010, the updated Plan entitled "Spill Contingency Plan, Fuel Facility Upgrade Project, Rankin Inlet." On Jan 12, 2010, the NWB acknowledged receipt of the Plan and distributed it for a public-review period with a comment deadline of February 12, 2010. In addition to comments received in the original application review, submissions were received from Indian and Northern Affairs Canada and Environment Canada. Following a review of the plan and submissions, the document does not fulfills the requirements of Part H, Item 1, of the Licence which states:

"The Licensee shall submit within thirty (30) days of issuance of the Licence, a Spill Contingency Plan, in the format set out by the Consolidation of Spill Contingency Planning and Reporting Regulations R-068-93 that addresses comments received by interested parties."

The NWB reminds the Licensee that a complete Spill Contingency Plan that addressees comments received was required by December 21, 2009. The Licensee is requested to submit a revised plan that addresses or includes the following prior to a Board Decision on the Plan:

- 1. Include the date the plan was prepared and the effective period of the plan;
- 2. Include the tank farm location in GPS coordinates;
- 3. Include a complete fuel/hazardous material inventory that is consistent with the application and hydrostatic testing procedures;
- 4. Include the 24-hr Spill Report Line and INAC's Manager of Field Operations contact number within the reporting section of the plan--(867)-920-8130 and (867)-975-4295 respectively);

- 5. Include step-by-step clean up instructions for the most likely spill scenarios on land, into water and on ice/snow;
- 6. Include disposal information for any contaminated soils and materials including relevant transporting procedures and obtaining permission for the use of local land farm facilities:
- 7. Include precise location of spill kits within the bermed area and a detailed inventory of the content of each spill kit;
- 8. Include information on training;
- 9. Include contact information for:
 - a. Environment Canada-867-975-46444
 - b. GN-Department of Environment-867-975-7700
 - c. Hamlet of Rankin Inlet
 - d. Kivalliq Inuit Association
- 10. Include a section on preventative measures in place;
- 11. Include a section on hazardous water/sludge collections, storage and removal; and
- 12. A more detailed description of the site along with the site's history is recommended.
