We officially awarded the contract to Biogenie SRDC Inc. and their primary subcontractor Wiinebek Management Inc., on April 16, 2010 and are currently preparing everything for the upcoming field season. A few highlights are provided below:

- Mobilization is scheduled to be begin during the first week of July
- Recruiting to begin around the end of May in Chisasibi, Waskaganish and Wemindji (66% Cree/Inuit employment)

- Field work will take place from mid-July until early November
- Community meetings will be held in Chisasibi prior to the start of work and again at the end of the field season
