## Hello Mark/Charlotte,

In regard to your amendment request for Land Use Permit #N2010X0005, issued for the Bear Island Mid-Canada Line Radar Station Remediation Project, the following consideration has been given.

As part of the remediation plan you have requested the permission to burn untreated and unpainted wood.

## Land Use Permit #N2010X0005 states:

### 31 (1) (c) - Equipment

- 10. The Permittee shall use a forced-air fuel-fired incinerator to incinerate all combustible garbage and debris.
- 11. The Permittee shall burn all combustible garbage and debris in a container acceptable to a Land Use Inspector.

Your proposed ash collection system, which allows for the containment of ash is considered to be a container acceptable to the Land Use Inspector. Therefore, your amendment request has been granted to allow for the burning of untreated and unpainted wood only.

It is our understanding that you have agreed to sample ash, when it is found to be non-hazardous the materials will be disposed of in the on-site Non-Hazardous Waste Landfill as approved by Land Use Permit #N2010X0005. Any material found to be exceeding Tier II contaminated soil criteria will be packaged and shipped off site to an appropriate disposal facility.

This amendment may require approval from the Nunavut Water Board, therefore, please contact them at the following address for any approvals that you may require:

Are we permitted to burn wood at Bear Island this summer? There is a lot of wood debris that is untreated and unpainted that we would like to burn. We would like to avoid placing this in our landfill as over the long term the wood will rot and have a negative impact on the integrity of our landfill. Shipping the wood off-site is a much more costly option and we do not have the budget to do this.

The Land Use Permit (#N2010X0005) contains a condition 31(1)(c) 11. that states:

" The Permittee shall burn all combustible garbage and debris in a container acceptable to al Land Use Inspector."

I asked Kevin Robertson about this and his interpretation was that all burning has to be done within the incinerator.

Is it possible for us to obtain permission to burn the wood in a fire pit or another acceptable container?
