Thank you for today's telephone conversation about your application to the Nunavut Water Board (NWB) for the Bathurst/High Arctic Remediation and Risk Management Project (NWB File No. 1BR-BIH----).

This email is intended as record of the conversation where you indicated that:

- The project schedule has been delayed one year and activities are now anticipated to occur in 2019
- You intend to provide NWB with a formal update and some additional project information in the next few weeks.

The NWB recommends that, given you have time, you should consider reviewing all of your submission documents and possibly submit a full update to the application. Some of the documents in the existing application still refer to a 2017 field program. The submission already includes previous revisions for timing and scope. A single clear submission might be simpler for reviewers and public interveners than multiple updates.
