Hi Tamara,

The Nunavut Water Board (“NWB”) acknowledges receipt on May 23, 2014 of your cancellation water licence application for the Cape Young Dewline Site Project, file number 1BR-CAP0914.

We undertook a preliminary administrative review of your application and conclude that, in accordance with approved legislation under the *Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* (“NLCA”), it does not contain sufficient information for the NWB to commence processing the file at this time. Specifically, we are asking you to provide the following:

- Annual Report for 2013 as required under Part B, Item1 in the licence;
- Sewage Disposal Facility Design as required 60 Days following issuance under Part H, Item 1;
- As-built drawings required within 90 days of completion of construction under Part H, Item 2.

We will resume processing your application once additional information has been received.
