*The NWB will need a revised version of the PIN-B (Clifton Point) Long Term Monitoring Plan, dated April 2011.*

Moreover, given that the landfill monitoring data presented in the 2013 and 2015 Long Term Monitoring Report revealed exceedances relative to the *Federal Interim Groundwater Quality Guidelines* (EC, 2010), will INAC be proposing better strategies in order to improve sampling results, as well as to ensure that well water is available for sampling during collection time?

As requested, please find attached the A&R Plan for 1BR-CLI0914 for the Board's consideration.

Also, please advise if a Spill Plan is required, despite no hazardous material at the site or being brought to the site (all the information requested below is no longer relevant to current site conditions). As part of our long term monitoring visits, a Health and Safety Plan is prepared and submitted as an appendix in the Long Term Monitoring Reports (Appendix D in the 2015 Report). In the Emergency Response Plan (Section 9), there is a subsection on Spills and Leaks (Section 9.7). Please confirm whether this is sufficient or whether a stand-alone spill plan is required.

1) As indicated in the review comments obtained on March 8, 2017, from INAC

Water Resource Division, the Licensee's existing Site Specific Spill Contingency Plan, Clifton Point PIN-B Cleanup. March 26, 2010, does not reflect the project's current status. It is specific to site remediation activities that were completed in 2010.

Please provide an updated Spill Contingency Plan that reflects the project's current status as well as the following:

- The updated INAC Manager of Field Operations Contact information.
- A plan for refuelling operations if this is done on site during onsite sampling activities; i.e It is unclear how refuelling is undertaken at the property and whether any preventative measures, secondary containment/drip tray, will be utilized.
- An action plan for containing spills that may occur on water, land or snow/ ice.
- An MSDS sheets for all chemical products on site (e.g fuel/gasoline) and an NT-NU Spill report template should be included/attached as appendices.

- An Aerial Map.
- If possible please indicate on the Aerial Map where a Spill

kit will be stored.

- Finally, also update the effective period noted in the Spill Contingency plan, and also mention the specific period of time you expect to be on site.

2) In keeping with the updates you are currently making for the Abandonment and Restoration plan (A&R) for 1BR-LOR, can you also provide a revised A&R for 1BR-CLI0914. It will be beneficial to have update A&R plans specific to the remediation activities. You can choose to update the existing A&R plan, or include an A&R section to the Long Term Monitoring Plan. This section will highlight what items remain on site, i.e monitoring wells/equipment, and how/when they will be removed from site.
