Good Morning,

On July 22, 2014, the Nunavut Water Board (NWB or Board) received an application for the renewal and amendment of Licence No. 1BR-CLI0914 (the Application) from Aboriginal Affairs and Northern Development Canada (AANDC), to allow for water use and waste disposal associated with a long-term monitoring program at the PIN-B Clifton Point Site.

Given that a complete application was only received after July 9th 2015, after the NuPPAA amendments were in effect. Please be advised that under the Nunavut Land Claims Agreement (NLCA), Article 11, Section 11.5.9 and s. 76 (1) of Nunavut Planning and Project Assessment Act (NuPPAA), the proponent of a project governed by NuPPAA is also required to submit a project proposal document (which may include the water licence application) directly to the Nunavut Planning Commission (NPC or Commission) for the NPC's determination regarding the applicable land use planning requirements and/or directions regarding whether the project is subject to screening by the Nunavut Impact Review Board. In particular, please note that as established under Articles 11, 12 and 13 of the NLCA, NuPPAA and Part 3 of the Nunavut Waters and Nunavut Surface Rights Tribunal Act, until the project has completed the applicable land use planning and assessment process required by the NPC and the NIRB, the NWB cannot issue a water licence. The NWB has placed in its Public Registry copies of the Application, all comments received, and communications issued on this subject/ for this file.
