Hi Assol,

Just to let you know that from now going forward, I will be helping out on the cancellation of the Contwoyto Lake file. Ms Neoma Cox has been moved on to handle other assignments.

On your email requests below: All activities on Contwoyto Lake were completed in Summer of 2015. We also submitted all WL annual reports for 2014 and 2015 to your office after project completion. There were no activities on Contwoyto Lake in 2016, nor in 2017. Therefore there are no needs to submit annual reports for these two years. I am working on the cancellation application now and I should send it to you COB today.

On your second question on surface water monitoring, our site assessment report and RAP indicated that the elevated metal levels are due to the background concentrations of the metals in the area and not on the legacy contamination (i.e. contamination from previous uses of the site). Our assessment and RAP consultant did due diligence of comparing the surface water in the ponds on the site to the other surface water samples collected from another pond further inland (1 km) (far away from Contwoyto Lake's previous activities). The consultant discovered that, though the parameter detected in the site's surface water samples are elevated compared to the CCME Fresh Water Aquatic Life (FAL) criteria they are similar to or below the concentrations found in the pond that is further (which represents the background concentrations). The comments in the completion report and by the Water Resources were probably made with little considerations of the background concentrations. Therefore it is INAC's position that no further water monitoring is required on the site.

In the meantime, I will send you the INAC cancellation application shortly.

Dear Peter Martin and Erika Solski,

I am a Nunavut Water Board technical advisor in charge of 1BR-CLR1419 (Contwoyto Lake Weather Station remediation site). I am looking into the cancellation application filed by INAC.

I was wondering if there was any work done on-site in 2017, as there have been no annual reports filed for that period. In addition, there was a recommendation in Arcadis' Completion Report, as well as an inquiry from INAC Water Resources, to collect and analyze surface water samples to monitor for exceedance in metals. Previously, INAC Contaminated Sites indicated that there were no further plans for long-term monitoring of the site, but did not address the situation with surface water sampling.

The other recommendation regarding the monitoring of regraded lands was positively addressed by the Inspector in her 2017 water licence inspection report.
