Hi All,

Please find below some updates to the Contwoyto Lake Remediation Project that were brought to our attention by a water licence inspection by Eva Paul on July 16, 2014.

In section 3 of the inspection report, there are 5 actions required. Please see below responses.

1) GPS Coordinates of the monitoring wells that were installed after the site inspection on July 16, 2014.

2) GPS Coordinates for the borrow area that was submitted under our Quarry Permit Application to AANDC Lands. Please see below Borrow Coordinates.

- Contact water is to be collected tested and treated as required as per licence conditions. Please see attached memo on contact water at Contwoyto Lake.
- 4) Please find attached stamped engineered drawings of the Landfarm design (Proposed in June 2014 and as built in July 2014).
- 5) Some slight changes to Part D 8. & 9. of the current water licence. All site greywater and sewage generated from camp operations were being contained and shipped off-site. These changes would have less impacts than what was originally proposed and actually exceeds the current water licence requirements.

This should address all of Section 3 of the Water Licence Inspection document from July 16, 2014. Please let me know if you require anything further.
