Subject: Cancellation of Licence No. 1BR-CLR1419

Dear Mr. Martin:

On January 17, 2017, Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) Contaminated Sites contacted the Nunavut Water Board (NWB or Board) with an application to cancel Licence No. 1BR-CLR1419 for the Contwoyto Lake Former Weather Station Remediation Project (the Project), as the scope of work had been fulfilled. In March 2017, the Licensee followed up with the request to cancel by submitting the 2016 Annual Report and the Final Remediation Completion Report. On September 20, 2017, NWB received a CIRNAC inspection report for the Project confirming that “(t)he project has been completed and all equipment removed. The site is well contoured with no signs of ponding in the excavated areas. Authorizing bodies may close/cancel this file at their discretion.”¹

The NWB made the application and all accompanying information available for public review and received comments from CIRNAC Water Resources inquiring whether long-term monitoring was required. The proponent informed that it did not consider any further monitoring necessary, as the objectives of the remediation project had been achieved.^{2,3}

By copy of this letter the Board approves the cancellation of Licence No. 1BR-CLR1419 through the Board Motion No. 2018-B1-024, dated August 13, 2018.
