The Nunavut Water Board ("NWB" or "Board") acknowledges receipt on November 8, 2016 of your new water licence application for the Cambridge Bay Soil and Water Treatment Facility Project, file number 1BR-CST---- and has completed its review of the above-mentioned application, which determined that the following information should be provided or issues addressed before the Board could proceed to the next stage(s) of the Licensing process for the file:

1. Submission of a Spill Contingency Plan;
2. Confirmation on whether or not the Soil and Water Treatment Facility (SWTF) is currently constructed. Page 9 of the *Closure and Reclamation Plan, Cambridge Bay Soil and Water Treatment Facility*, dated April 2016, states that the facility was scheduled to begin operation in the summer of 2016.
3. Confirmation on whether or not permission is requested from the Hamlet of Cambridge Bay to dispose of treated soil at the Hamlet's landfill during operation of the SWTF and the liner following closure of the facility.
