Dear Mr. Omilgoitok:

On April 1, 2020, the Nunavut Water Board (NWB or Board) received an application to assign the Licence 1BR-CST1723 (Licence) from Kitnuna Environmental Ltd. (Assignor) to Kitikmeot Environmental Ltd. (Assignee) pursuant to Section 44 of the *Nunavut Waters and Nunavut Surface Rights Tribunal Act (Act)*.

Following internal review of the application by the NWB and provision of additional information by the Assignee, the Board gave public notice of the application for assignment on April 17, 2020, and invited interested persons to provide comments. No comments were received and no adverse environmental effects were identified by the NWB that would result from the assignment of the Licence to Kitikmeot Environmental Ltd.

Pursuant to Section 44(1) of the Act, the Board is satisfied that the assignment of operation of the appurtenant undertaking by the prospective Assignee is unlikely to result in a contravention of any condition of the Licence or any provision of the *Act* or the regulations. Therefore, in accordance with Section 44(2) of the *Act*, the Board hereby authorizes the assignment of Water Licence 1BR-CST1723 from:

the Assignee, Kitikmeot Environmental Ltd.

(**Motion #2020-B1-008**) effective on May 22, 2020, will be placed on the NWB Public Registry.

All terms and conditions of this Licence remain in effect. Sections 85 to 94 of the *Act* provide the provisions for the enforcement of this Licence. The Minister of Northern Affairs has the power to designate inspectors and/or analysts to identify or determine inspection and compliance related issues. The NWB recommends that Kitikmeot Environmental Ltd. contact the Inspector for CIRNA in Iqaluit to obtain a copy of any enforcement documents related to this Licence.
