Dave,

I finally had a chance to thoroughly review and provide the following comments / requests re 1BR-CUL0708. If the NWB would consider this for the for the existing licence and next amendment, it would be appreciated:

Part B, Item 6, 7 and 8: "Monitoring Program" in 6 and 7 should be changed to the "Surveillance Network Program" (as indicated in Item 8)

Part B, Item 10: This item should be deleted since none are required.

Part D, Item 7: Change "proponent" to "Licensee"

Part E, Item 1: We should add a definition for "Camp" in Part A since I assume the NWB is referring to a facility that requires the taking of measurable amounts of water. I make this suggestion since there is always the possibility of getting stranded on this site for several days, requiring us to erect a few survival tents around a campfire. In addition, from time to time I may have maintenance work that could last more than one day, again requiring us to pitch tents for one or two nights.

Part I:

Item 5 -15: While most of the issues mentioned in these items are in fact already closed out or resolved as stipulated, or do not apply, they were not specifically itemized in this manner in previous licenses or in the approved Plan. We should therefore delete 5 -15. For your comfort, you could modify Item 4 to read: "the Licensee shall complete all reclamation and monitoring work as specified in and within the time schedule specified in the approved...."
