The Nunavut Water Board (NWB or Board) has completed its review of the following documents submitted to satisfy the relevant requirements of the Licence issued to the DYE-M, Cape Dyer, DEW Line Site Remediation Project, situated approximately 150 kilometres southeast of Qikiqtarjuaq in the Qikiqtani Region, Nunavut:

- 2012 Annual Report Submitted on March 18, 2013 by AECOM Canada Ltd., on behalf of Defence Construction Canada and the Department of National Defence;
- 2013 Annual Report Submitted on March 10, 2014 by AECOM Canada Ltd., on behalf of Defence Construction Canada and the Department of National Defence, and distributed on May 13, 2014; and
- 2014 Annual Report Submitted on March 5, 2015 by Defence Construction Canada on behalf of the Department of National Defence, and distributed on March 6, 2015.

The review determined that the 2012 and 2013 Annual Reports are generally complete and consistent with the reporting requirements under Part B, Item 1 of Licence No. 1BR-DYE0914. The 2014 Annual Report, however, was found to be deficient with respect to the following information, which the Licensee is required to submit for review within <u>sixty (60) days</u> from the date on this correspondence:

Monitoring results and information for the 2014 reporting period; and

• Photographic information to complement the summary of work completed during the 2014 reporting period.
