Unfortunately, we do not have as-built drawings available. Engineers typically do not monitor the construction of short-term temporary works to the level of detail required to produce stamped as-built drawings. The River Crossings we installed were removed at the end of the 2006 and 2007 field seasons and will be reinstalled and removed again in 2008.
