**Subject: Notice of Modification to Landfarm and Notice of Modification to Landfill; Licence 1BR-EKA0607, Part G, Item 2**

Dear Mr. Spagnuolo;

The Nunavut Water Board ("NWB") would like to acknowledge the receipt of the above two notifications under Part G, Item 2 of Licence 1BR-EKA0607. The two requests, received on May 11, 2007 and August 3, 2007 respectively were distributed for review and comment to interested persons.

A technical review of the notification and planned modifications has been completed. No immediate concerns were identified by interested persons during this review period. The Board has taken into consideration the information submitted and hereby accepts the proposed construction modifications as described in the submitted documents.

Further to the above, the NWB has noted in its review of this file and the above notification, that an Operations and Maintenance Manual for the Waste Disposal Facilities has not been filed with the NWB and will be a requirement of this authorization.

The NWB requests that, the Licensee provide to the Board within ninety (90) days of issuance of this letter, the following:

- i. As-built drawings, stamped by a qualified engineer, registered in Nunavut, for the modifications to construction of facilities that have changed from the original designs that were submitted by the applicant for the modifications described in the notification above.
- ii. Submit the details of the proposed dust control program and how that will affect the overall water consumption for the project.
- iii. Identify and make the necessary revisions to the monitoring stations, installation of monitoring wells and their new locations if applicable, that are to be included as part of the "Monitoring Program" provided with the application documents along with supplemental information.
- iv. The Licensee shall prepare and submit to the Board for approval, a Plan for the Operation and Maintenance of the Sewage and Solid Waste Disposal Facilities (including the Landfarm) in

accordance where appropriate, with the “*Guidelines for Preparing an Operation and Maintenance Manual for Sewage and Solid Waste Disposal Facilities*”, GNWT (October 1996). This Plan is to consolidate the application materials, additional information received during the Licensing process and the proposed modifications, to provide a comprehensive Operations and Maintenance Manual.

- v. The Licensee shall implement the Plan specified, as and when approved by the Board.
- vi. The Licensee shall revise the Plan if not acceptable to the Board and submitted to the Board for approval within thirty (30) days of notification of the Board decision

The requirements of this authorization letter form an integral part of Licence 2BR-EKA0607.
