Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and the Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following license amendment. This amendment is effective upon consent of the Minister of Indian and Northern Affairs Canada pursuant to s. 55(5) of *Nunavut Waters and Nunavut Surface Rights Tribunal Act*.

The License issued June 19, 2006 shall be amended to include the following terms and conditions to allow Indian and Northern Affairs Canada to construct culvert crossings at River Crossings #1 and #2 as proposed in the emergency amendment application instead of the porous embankments as proposed in the licence application.

PART E: CONDITIONS FOR CAMPS, ACCESS INFRASTRUCTURE AND OPERATIONS

- Amend Item 5 With respect to culvert installation, the Licensee shall comply with the recommendations in the Culvert Assessment FOX-C DEWline Site Ekalugad Fjord, NU conducted by EBA Engineering Consultants Ltd, except for River Crossings #1 and #2 the Licensee is authorized to install culverts as per the documentation submitted with the emergency amendment application.
- Insert Item 16 The Licensee shall submit for Board approval 60 days after construction of the proposed culvert design for River Crossings #1 and #2, as-built drawings stamped by an Engineer and field decisions made during construction that deviate from the proposed plans and any data used to support the changes.

All terms and conditions of the License 1BR-EKA0607 Type "B" dated June 19, 2006 still apply.
