Re: Amendment/Renewal - Defence Construction Canada 1BR-FOD0813 – FOX – 3 Dewar Lakes

1. Project Description

FOX – 3, Dewar Lakes is one of the Department of National Defence (DND) North Warning System (NWS) Long Range Radar sites. Due to ongoing facilities use, most of the infrastructure was not slated for demolition and no remedial activities have been completed within operational areas. FOX – 3 is located on central Baffin Island approximately 200km to the southwest of Clyde River.

The original Distance Early Warning (DEW) line system was decommissioned in 1991. DND in cooperation with Nunavut Tunngavik Incorporated (NTI), developed a landfill monitoring plan to address post closure monitoring requirements for landfills at DEW Line Sites in Nunavut (pursuant to the September 1, 1998 Department of National Defence – Nunavut Tunngavik Inc. Agreement for the Cleanup and Restoration of DEW Line Sites within the Nunavut Settlement Area). Defence Construction Canada will be managing the clean-up and monitoring on behalf of DND. The objective of the program is to collect sufficient information to assess the performance of landfills from a geotechnical and environmental perspective. Program components consist of visual monitoring, soil monitoring, groundwater monitoring, and thermal monitoring.

The program schedule is a three (3) phased approach with monitoring occurring in years 1 through 5 in Phase I. The second phase monitoring schedule is years 7, 10, 15, and 25, with year 25 marking the end of Phase II monitoring. A re-evaluation of the monitoring program will be carried out during Phase III. The scope of Phase III has not been determined; however it is anticipated to be based on a 10 year monitoring interval.

A licence term of 23 years is being requested with water use limited throughout the licence term. No water will be used for domestic or construction purposes. Small quantities (approximately 1L) of water will be taken from existing monitoring wells to carry out the groundwater monitoring component of the program.

Results of Review and Recommendations

AANDC Water Resources Division offers the following comments/recommendations for the Board's consideration.

A. General
