LICENCE AMENDMENT No. 1

Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and the Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following license amendment.

The License issued August 4, 2004 shall be amended to include the following terms and conditions, with respect to use of water and deposit of waste, in support of the DEW Line Clean-up activities, specifically the Landfill Monitoring Program, at the FOX-4 DEW Line Site, Cape Hooper, Baffin Region, Nunavut (located at Lat. 68° 26'N and Long. 66° 44'W).

PART A: SCOPE, DEFINITIONS & ENFORCEMENT

1. Scope

Amend Item (i)	This Licence entitles Defence Construction Canada (DCC) to use water and dispose of waste during operations associated with a site investigation being completed to delineate the extent of contamination present at FOX-4 Distant Early Warning (DEW) Line Site, Cape Hooper, Baffin Region, Nunavut (68°26'N; 66°44'W). Activities include construction camp mobilization and operation, re-packaging of previously collected PCB-amended painted material for shipment to an approved PCB-management facility and Monitoring as described in the plan entitled "Defence Construction Canada, Landfill Monitoring Program, FOX-4, Cape Hooper" prepared by UMA Engineering Ltd., during site remediation activities on the FOX-4 DEW Line site.

Amend Item 2	The Licensee shall minimize disturbance to terrain, permafrost and drainage features during movement of contractor's equipment and personnel around the site, during the removal of materials from the site and in carrying out the requirements of the monitoring program as per Part H, Item 5.



Insert Item 6 The Licensee shall include the results, along with an interpretation of the results of the monitoring, in the Annual Report as required by Part B, Item 1(iii).

All remaining terms and conditions of the License NWB5FOX0406 Type 'B' dated August 4th, 2004 still apply.
