Good afternoon Phyllis,

Thank you for following up.

This project remains very active. In October, we received revised Preliminary Project Approval with authority to engage in Phase 1 implementation, from the Minister of National Defence.

What this means is that we have received increased funding to implement the project. We are currently in the process of negotiating a design contract with the equipment manufacturer and expect to publish a requirement for a 3-year camp contract, with mobilization to occur later this year.

We want to be on site by mid-late summer, though the exact scope of work is still being defined.

All that to say that we are very active now; we were in a holding pattern until our funding was approved.

So yes, we would like to keep the application open and hopefully we will be able to have this complete in the New Year.

I hope this answers your concerns.
