Technical Review Memorandum

Indigenous and Northern Affairs Canada's (INAC) Review of Transport Re: Canada's Renewal Application for Water Licence 1BR-FTA1217 for the Firefighting Training and Apron Areas Remediation Project at the **Cambridge Bay Airport**

A. BACKGROUND INFORMATION

On September 11, 2017 the Nunavut Water Board provided notification to interested parties that Transport Canada (the Licensee) had submitted a renewal application for their Type 'B' water licence #1BR-FTA1217.

The Hamlet of Cambridge Bay is located on Victoria Island in the Kitikmeot Region, Nunavut. The existing licence authorized the deposit of waste during activities associated with the remediation of hydrocarbon contaminated soils identified at both the Firefighter Training and Apron areas at the Cambridge Bay Airport. In addition to constructing a land treatment facility to remediate contaminated soils at both sites, a groundwater monitoring program was also established. Water use is not authorized under the existing licence.

The Licensee is requesting a ten year term renewal. The application is not seeking any amendments to the existing licence. Interested parties were requested to review the renewal application and provide comments by October 11, 2017.

B. RESULTS OF REVIEW

1. Updated Plans Submitted to the Board

INAC request a confirmation from the Licensee that the existing plans remain valid and in place under this renewal application. If this is not the case, INAC requests that the Licensee file updated plans with the Board for review.



2. Elevated Levels of Metal Concentrations

The 2016 Annual Report Executive Summary indicated that poly- and perfluoroalkyl substances were above Federal Environmental Quality Guidelines for aquatic receptors in the sump water's analytical results at the fire training area land treatment unit and that soil analytical results from the land treatment units at both sites indicated elevated levels of petroleum hydrocarbon fractions (PHCs). INAC requests clarification if these issues have been addressed as well as clarification on how they were addressed.

3. 2016 Annual Report

The January 2017 reports providing complete details regarding the works undertaken in 2016, which are alluded to in the 2016 Annual Report entitled: "Site Remedial Activities Supervision and Monitoring Program at the FTA" and "Site Remedial Activities Supervision and Monitoring Program at the Apron Areas" do not appear to be made available on the Nunavut Water Board Public Registry. INAC requests that the Licensee ensures a copy is provided to the Board for review.

4. Term of Licence

The Licensee is seeking a ten year term under their renewal application for the existing licence. INAC is in support of a ten year term renewal licence.
