As you are aware most of the DEW Line sites are now in the long term monitoring phase of remediation. The current agreement between DND and NTI has the monitoring structured to include; Phase I (years 1-5 post construction), Phase II (years 7, 10, 15, and 25) and Phase III (yet to be determined). I have enclosed the reports generated by the monitoring contractors for the 2012 field season. Below is a summary of what occurred at each of the sites; please notice for those sites where no activity occurred in 2012 no annual report will be submitted to the NWB.
