Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters* and the *Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following license amendment.

The License issued April 18, 2003 shall be amended to include the following terms and conditions to allow Defence Construction Canada to increase their water use from 30 cubic meters a day to 100 cubic meters a day.

PART C: CONDITIONS APPLYING TO WATER USE

Amend Item 3 The daily quantity of water obtained for all purposes shall not exceed 100 cubic metres.

All terms and conditions of the License NWB5HAL0308 Type "B" dated April 18, 2003 still apply.
