Thank you for your September 11, 2020 invitation to comment on the Abandonment and Restoration Plan from Transport Canada (TC) under the 1BR-IAG1924 Water Licence. Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) has conducted this review pursuant to its mandated responsibilities under the *Nunavut Waters and Nunavut Surface Rights Tribunal Act* and the *Department of Crown Indigenous Relations and Northern Affairs Act*, and other associated legislation and policies. CIRNAC has not identified any issues with the plan. Please find below CIRNAC comment and recommendation;

CIRNAC Comment: The Abandonment and Restoration Plan September 2020, indicates that "Following the completion of work, and prior to March 31st, 2021, TC will provide a description of the work completed and photos of the restoration to the Nunavut Water Board". CIRNAC appreciates this plan by the TC. The before and after photos of the site will provide a complete picture of the abandonment and restoration work completed.

CIRNAC Recommendation: CIRNAC recommends that TC also include the before restoration photos of the site to the planned 'photos of restoration' that will be sent to the Nunavut Water Board.
