Re: Notice of Screening for Kudlik Construction Ltd.'s "Backup Asphalt Plant to IIAP Project and Batch Plant" project proposal

Dear Stéphane Gélinas:

On September 4, 2015 the Nunavut Impact Review Board (NIRB or Board) received a referral to screen Kudlik Construction Ltd.'s (Kudlik Construction or the Proponent) "Backup Asphalt Plant to IIAIP [Iqaluit International Airport Improvement Project] Project and Batch Plant" proposal from the Nunavut Planning Commission (NPC or Commission). Pursuant to section 86 of the *Nunavut Planning and Project Assessment Act* (NuPPAA), the NIRB has commenced screening this project proposal and has assigned it file number 15XN046 - please reference this file number in all future related correspondence.

INFORMATION REQUEST

Following a preliminary completeness check, the NIRB determined that the proposal as submitted did not contain the necessary information for the NIRB to carry out its screening. On September 14, 2014 the NIRB requested that Kudlik Construction provide additional information in support of this proposal. On September 28, 2015 the NIRB received additional information from Kudlik Construction in support of this proposal, but upon review of the submission found that it was still insufficiently developed to permit proper screening and distribution for public comment and requested that the additional outstanding information from the Proponent on September 30, 2015. By October 2, 2015 the NIRB received the requested additional information to commence with the screening.

PROJECT SCOPE

Project Scope:

The proposed "Backup Asphalt Plant to IIAIP Project and Batch Plant" would be located within the Qikiqtani region, adjacent to the Iqaluit International Airport runway in Iqaluit. The Proponent intends to construct and operate an asphalt batch plant to produce hot-mix asphalt as a

backup for the IIAIP project which will be used in municipal projects, including paving of roads and parking lots. Construction is proposed to commence in July 2016 with operations of the plant to commence in September 2016 and continue to 2026 or potentially longer.

According to the project proposal, the scope of the project includes the following works or activities:

- Construction, operations, maintenance and decommissioning of a hot-mix asphalt batch
- Shipment of construction materials, asphalt batch plant and related materials to Iqaluit via
- Transportation of construction materials, asphalt batch plant, and operations materials via existing access roads to the proposed site;
- Transportation of the asphalt product to municipal projects;
- Stockpiling and crushing of aggregate materials;
- Storage and use of bitumen for the production of asphalt;
- Storage and use of diesel fuel (40,000 litres);
- Use of heavy equipment to haul materials and asphalt product;
- Production of human and grey water waste;
- Disposal of sewage and grey water wastes by local company; and
- Removal of crushed bitumen drums for disposal at an appropriate southern facility.

At this time, the NIRB has identified no additional works or activities in relation to the project proposal. As a result, the NIRB will proceed with screening the project based on the scope as described above.

- Whether the project proposal is likely to arouse significant public concern; and if so, why;
- Whether the project proposal is likely to cause significant adverse eco-systemic or socioeconomic effects; and if so, why;
- Whether the project is likely to cause significant adverse impacts on wildlife habitat or Inuit harvest activities; if so, why;
- Whether the project is of a type where the potential adverse effects are highly predictable and mitigable with known technology, (please provide any recommended mitigation measures); and
- Any matter of importance to the Party related to the project proposal.
