I am sorry I dropped the ball on this your email. Please see my responses to your 2 questions as follows:

1. All reasonable attempts will be made to avoid the berms being breached during the landfarming activities. In other words, the berms will be in place until all the contaminated soils have been confirmed clean.
2. I am working on the 2017 Annual Report for CAM-E and a couple of other projects. I will get most of them to you next month (July). We have been having capacity challenges for quite some time. We hope to be up to date on these

files very shortly.
