Pursuant to its authority under Article 13 of the Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada and the Nunavut Waters and the Nunavut Surface Rights Tribunal Act, with respect to an application by Indigenous and Northern Affairs Canada (INAC), dated August 10, 2017, to amend the water use provisions under Part C, Item 1 of Licence No. 1BR-KEI1722, the Nunavut Water Board hereby grants the following Licence amendment.

The Licence issued on January 17, 2017, modified on August 8, 2017, and set to expire on January 19, 2022, shall be amended to include the following terms and conditions with respect to the Use of Water and/or the Deposit of Waste at the CAM-E (Keith Bay) Site Remediation Project, Located in the Kitikmeot Region, Nunavut, at the following general geographic coordinates:

D. GENERAL CONSIDERATION

Water Use (Page iv) Shall be Amended to Read:

The Applicant requested, under Amendment No. 1, the use of approximately forty (40) cubic metres of Water per day in support of domestic, construction, and reclamation activities associated with the Project, which the Board considers reasonable and consistent with the type of undertaking involved and, therefore, granted under Part C, Item 1 of the Licence amendment. Water for domestic use shall be obtain from a freshwater lake located near the camp facility whereas water for construction and reclamation activities shall be obtained from seasonal wet areas near borrow sources used by the project.

Preliminary water samples taken from the proposed domestic source indicate that coliform levels exceeded Health Canada Guidelines; however, it is anticipated that with adequate treatment the Water will be suitable for potable use. Upon initial arrival on site and prior to setting up its water treatment facility, the proponent indicated that it will use bottled water temporarily. Once the treatment facility is established, raw water withdrawn from the source will be transported to the Project site using a transmission line or truck.

PART C: CONDITIONS APPLYING TO WATER USE

Amend Item 1 to Read:

The Licensee is authorized to withdraw, from a freshwater lake proximal to the camp facility, up to five (5) cubic metres of water per day for domestic use at Monitoring Station No. KEI-1. For construction and reclamation activities, the Licensee is allowed to use up to thirty-five (35) cubic metres of water per day with water for such purposes coming from seasonal wet areas proximal to the borrow sources used by the Project. The total quantity of water authorized for all purposes under the Licence shall not exceed forty (40) cubic metres per day.

All remaining terms and conditions of the Licence No. 1BR-KEI1722 and/or 1BR-KEI1722 – Modification No.1, Type "B", issued January 17, 2017 and August 8, 2017, respective, remain applicable.
