Hi Michael,

Thanks for the quick turn-around regarding the Spill Contingency Plan (SCP) for the FOX D Project.

A preliminary review of the Plan determined that the following items should be addressed / included:

- The effective date of the Plan;
- A site location map depicting camp infrastructure, surrounding water bodies, spill response equipment, hazardous material location, and other relevant details, if currently known;
- An inventory of hazardous materials stored onsite;
- Specific spill response measures for potential spills on land, water, and snow/ice;
- A copy of the NWT NU spill report form;
- Material Safety Data Sheet for hazardous materials stored onsite or details related to where they can be found;
- Storage of equipment or hazardous material should be at minimum of thirty-one (31) metres from the ordinary High Water Mark instead of the thirty (30) metres mentioned in the Plan;

Notwithstanding changes requested above, if you would like for the NWB to distribute the Plan in its current form, please confirm as your earlies convenience.

It would be rather difficult for the NWB to issue a licence for the project in the absence of a Spill Contingency Plan; therefore, submission of the plan, which will require a minimum of thirty (30) days public review, should occur sooner rather than later.
