Failure to address the deficiencies before the NIRB resumes the screening process may result in a suspension of the Board's assessment activities pursuant to Section 144(2) of the NuPPAA until the information is provided.

If AANDC determines that the time required to supply the required information is significantly greater than 2 weeks, the Board requests written notification and an anticipated date for submission be provided as soon as possible.
