A. BACKGROUND

On August 3, 2017 the Nunavut Water Board provided notification to interested parties that Indigenous and Northern Affairs Canada- Contaminated Sites Division. (Licensee) had submitted an open burning request

FOX-D Kivitoo Lake was a Distant Early Warning (DEW) Line site and is located on the David Strait within the Qikiqtani Region: the nearest community is Qikiqtarjuag. Nunavut. The FOX-D DEW Line site was constructed in 1957 and operated until 1963. The site is composed of two areas: the Upper Site and Lower Site. All structures at both areas of the site were removed to their foundations, with the exception of two vertical fuel storage tanks and a smaller transfer tank left in place at the upper site.

The Licensee is requesting a Burn Permit for the FOX-D Kivitoo Site Remediation Project to burn unpainted/untreated scrap wood removed from numerous landfills.

If approved for open burning a contractor plans to have two burn pits; one will be located at the upper site and the other located at the lower site. Fire Extinguisher training will be provided by the on-site health and safety officer for proper fire response.

All interested parties were asked to review the Water Licence renewal application and provide technical comments by August 11, 2017.

A. RESULTS OF REVIEW

Indigenous and Northern Affairs Canada- Water Resource Division submits the following comments to the Nunavut Water Board for consideration:

1. Open Burn Request

First INAC would like to state that it does not encourage open burning. Past experience indicates that it may be difficult for licencees to know at times whether or not they are burning so called "clean materials "however, if open burning were to occur, it should be done in a manner that does not allow contaminated ash to enter into water, either directly or indirectly. All ash should be treated as contaminated material and thus stored and shipped off site appropriately.
