Phyllis: The required documents have been drafted and are going to our client today for a final review. Once we receive their comments we will prepare the final versions and forward them to your office in electronic and hard copy format by the end of the week. I have a couple of issues that still need to be clarified:

- 1. On December 9 I had sent an e-mail to your office requesting clarification on whether a spill plan was still required for the Kugaaruk site. I don't have a record of a response on that matter. I believe that you were going to refer the matter to your technical officer.
- 2. Your December 8 message includes a comment that the Nunavut Impact Review Board had not been contacted to conduct a screening and that this must still be done. The first paragraph in the Decision section of the Oct. 13, 2006 Licence states that "the application was in conformity with the applicable Land Use Plan and exempt from the requirement for screening by the Nunavut Impact Review Board in accordance with Schedule 12.1, Paragraph 5 of the Nunavut Land Claim Agreement …..". Based on this statement NIRB screening had not been pursued. Can you confirm if the NWB position as stated in the original landfarm licence is still in effect or if there has been a change since the original application which would now require NIRB screening?
