Subject NWB Water Licence No. IBR-KRKIII2 - Request for Renewal

Tetra Tech WEI Inc. (Tetra Tech) has been retained by the Government of Nunavut Department of Community & Government Services (GN-CGS) to ensure that petroleum hydrocarbon impacted soil landfarm facility located in the Hamlet of Kugaaruk, Nunavut, is being operated in compliance with the conditions of the existing Nunavut Water Board (NWB) water licence, no. IBR-KRK!!!2. Tetra Tech (named Wardrop Engineering Inc. at the time) was previously involved in the design of the landfarm and the application for a NWB water licence at the Kugaaruk landfarm facility for GN-CGS. Tetra Tech requests that the NWB renews the existing water licence, which will expire on December 3!, 20!2, for two years.

BACKGROUND

Noted in the original application, dated May 25, 2005, the Kugaaruk landfarm facility was constructed prior to the issuance of a water licence. The impacted soil from a tank site remediation project in Kugaaruk was placed in the cell in July 2007, after the issuance of the NWB water licence no. 8BR-KRK0609. No additional soil has been placed in the treatment cell by GN-CGS since that time; however, unauthorized dumping of soil, debris, and greases by an unknown party has occurred on multiple events.

Composite samples of the soil in treatment cell were collect by Tetra Tech staff in 2007, 2009, 2010, and 2011. The upper soil layer was tilled and water from the runoff water retention cell was discharged by the CN-CGS contractor in 2009, 2010, and 2011. Tetra Tech installed groundwater monitoring wells on the down-gradient side adjacent to the landfarm facility in 2009 and on the up-gradient side adjacent to the landfarm in 2010. In 2010 Tetra Tech designed a splash pad, for the effluent to be directed to during discharge of the runoff water retention cell, which was constructed adjacent to and west of the landfarm by the GN-CGS contractor. Due to budget restrictions the landfarm operations in 2012 were limited to the discharge of the runoff water retention cell and pre and post discharge sampling conducted by the GN-CGS contractor.

REQUEST FOR LICENCE RENEWAL

Three compliance issues are related to the conditions of the exiting NWB water licence, no. IBR-KRK1112, and are as follows:

- 1. Notice was not given prior to the planned discharge of the runoff water retention cell as described in Part D, item 3 of the existing license.
- 2. Signage has not been posted as described in Part B, item 6 of the existing licence.
- Revisions to the plan entitled "Interim Abandonment and Reclamation Plan, Kugaaruk Landfarm" dated February 2010, have not been submitted as described in Part I, item I of the existing license.

Due to budget restrictions the landfarm operations in 2012 were limited to the discharge of the runoff water retention cell and pre and post discharge sampling conducted by the GN-CGS contractor. Notice was not given prior to the planned discharge of the runoff water retention cell as described in Part D, item 3 of the existing license because there was a concern that weather conditions could result in the inability to discharge the water contained in the cell prior to winter freeze-up. Tetra Tech reviewed the pre discharge sampling analytical results and did not identify the presence of any of the contaminants of concern related to the Kugaaruk landfarm facility, and the GN-CGS contractor was directed to



proceed with the discharge of the runoff water retention cell. The post discharge sampling analytical results did also did not identify the presence of any of the contaminants of concern related to the Kugaaruk landfarm facility. Mr. Andrew Keim, a Nunavut Region Water Resources Officer with Aboriginal Affairs & Northern Development Canada, was notified of this discharge in an email, Subject: Notice of discharge at Kugaaruk Landfarm Facility (NWB Licence No. IBR-KRKIII2), dated December II, 2012.

Since operations are expected to continue at the Kugaaruk landfarm facility, in the coming spring signage will be posted around the facility as described in Part D, item 3 of the existing license, in order to alert deter potential trespassers and discourage unauthorized dumping.

Revisions have been made to the plan entitled "Interim Abandonment and Reclamation Plan, Kugaaruk Landfarm" dated February 2010, and are presented in the plan entitled "Interim Abandonment and Reclamation Plan, Kugaaruk Landfarm Facility" dated December 2012, along with the documentation supporting the completed NWB form, Application for Water License Renewal.

Also, revisions have been made to the report entitled "Kugaaruk Landfarm Facility – 2011 Annual Report" dated September 2012. A letter from Tetra Tech to GN-CGS, dated December 19, 2012, explains that a guideline was incorrectly presented in the first submission of the report, and the correction is presented in the report entitled "Kugaaruk Landfarm Facility – 2011 Annual Report" dated December 2012. The revised report dated December 2012, and the letter dated December 19, 2012, are included with this request for renewal.

On behalf of the GN-CGS, Tetra Tech requests that the NWB renew the existing water licence for an additional two years. The following list details the documentation which has been included with this letter to support the request for license renewal:
