Re: Application Exempt from the Requirement for Screening pursuant to Section 12.4.3 of the NLCA: Defense Construction Canada's "FOX-2, Longstaff Bluff DEW Line Site Clean-up" project

Dear Jeff Mercer:

On October 25, 2012 the Nunavut Impact Review Board (NIRB or Board) received an application from Aboriginal Affairs and Northern Development Canada (AANDC) for an extension to the Land Use Permit (No. N2007X0035) for Defense Construction Canada's "FOX-2, Longstaff Bluff DEW Line Site Clean-up" project.

Please be advised that the original project proposal (NIRB File No.: 07DN066) was received by the NIRB from Indian and Northern Affairs Canada (INAC; now AANDC) on September 4, 2007 and was screened in accordance with Part 4, Article 12 of the Nunavut Land Claims Agreement (NLCA). On October 19, 2007 the NIRB issued the enclosed NLCA 12.4.4(a) screening decision to the Minister of INAC indicating the proposed project could proceed subject to the NIRB's recommended project-specific terms and conditions.

Additional authorization and extension requests associated with the "FOX-2, Longstaff Bluff DEW Line Site Clean-up" project have also been reviewed by the NIRB following screening of the original project proposal (File No. 07DN066). In each instance the NIRB confirmed that the applications were exempt from the requirement for further screening pursuant to Section 12.4.3 of the NLCA and the activities therein remained subject to the terms and conditions recommended in the original October 19, 2007 Screening Decision Report. A summary of the additional AANDC applications associated with NIRB File No. 07DN066 are presented in Table 1.

PREVIOUSLY-SCREENED PROJECT PROPOSAL:

As previously screened by the NIRB (File No. 07DN066), Defence Construction Canada's "FOX-2, Longstaff Bluff DEW Line Site Clean-up" project was located within the Qikiqtani region, approximately 245 kilometres (km) to the East of the community of Hall Beach. The Proponent indicated that it intended to conduct remediation activities each year during the summer field season (June to October) from 2008 to 2012.

The activities/components associated with the previously screened proposal included:

- Construction and operation of temporary and seasonal camp
- Demolition of existing facilities
- Remediation of the existing landfills
- Construction of two new landfills
- Excavation of contaminated soils
- Removal of surface debris around the site
- Land farming operation
- Grading and restoration of the site
- Return of the previous Quarry Permit and subsequent application for a new Quarry Permit

CURRENT APPLICATION:

Defence Construction Canada is proposing to extend its AANDC Land Use Permit (No. N2007X0035) in order to complete the clean-up and remediation of the Project. Application materials indicated that DCC anticipates the materials currently in the temporary PCB storage area will be removed in 2013.

Please note that Section 12.4.3 of the NLCA states that:

"Any application for a component or activity of a project proposal that has been permitted to proceed in accordance with these provisions shall be exempt from the requirement for screening by NIRB unless:

- (a) such component or activity was not part of the original project proposal; or
- (b) its inclusion would significantly modify the project."

After completing a review of the information provided in support of the current application, the NIRB is of the understanding that the proposed extension does not change the general scope of the original project activities, and the exceptions noted in NLCA 12.4.3(a) and (b) do not apply. Therefore, this application is exempt from the requirement for screening as per Section 12.4.3 of the NLCA and the activities therein remain subject to the terms and conditions recommended in the original October 19, 2007 Screening Decision Report (enclosed).
