Hello Joseph,

Thank-you for your message regarding the recent board memo you received for application 1BR-LON1422. It's good to hear from you, I hope you're well!

In response to your questions:

- 1. You are correct. Hall Beach is located approximately 245 km west of the proposed project site. This was an oversight on our part that will be corrected and will be reflected in the final licence (if approved). All three communities will be mentioned.
- 2. As you know, the applicant requested a 23-year licence term. A licence term of 8 years was proposed because that is the duration of time it will take the applicant to finish collecting all monitoring data needed to assess Phase I of the Monitoring Program, while further completing two Phase II monitoring events in 2018 and 2021 (i.e. this 8-year licence term takes into account the additional time needed to synthesize the first part of Phase II monitoring results into the program and to make recommendations as may be necessary before considering the licence for renewal in 2022). Ultimately, this period of time provides the NWB and its partners the amount of data needed to properly evaluate the effectiveness of the remediation program and the adequacy of the monitoring program.
