Technical Review Memo

Re: Operation and Maintenance Plan – Defence Construction Canada – 1BR-LON0813 – FOX-2 Longstaff Bluff, DEW Line Site

BACKGROUND:

The FOX-2, Longstaff Bluff DEW Line Site is located on the southwestern coast of Baffin Island in the Nunavut Territory. The site is approximately fifteen (15) km inland from the airstrip on the southern end of a small peninsula jutting into Nauja Bay. The nearest community is Hall Beach, 245 km to the west.

The purpose of the proposed remediation project is to clean-up previous activities that occurred because of the operation of the former DEW Line site. Specifically, the clean up is to prevent the release of physical debris and /or contaminants into the environment.

- Operation and Maintenance Plan

All associated documents related to this license posted on the NWB ftp website under 1BR-LON were included in my review.
