

# LICENCE AMENDMENT No. 1

Pursuant to its authority under Article 13 of the *Agreement between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* and the *Nunavut Waters and the Nunavut Surface Rights Tribunal Act*, the Nunavut Water Board hereby grants the following licence amendment.

The Licence issued August 5, 2003 shall be amended to include the following terms and conditions to allow for trenching operations:

## **PART A: SCOPE, DEFINITIONS AND ENFORCEMENT**

Amend Item 1(i) This Licence entitles Defence Construction Canada (DCC) to use water and dispose of waste during operations associated with a site investigation being completed to delineate the extent of contamination present at the FOX-2 Distant Early Warning (DEW) Line Site, Longstaff Bluff, Baffin Island, Nunavut (68°54'N; 75°10'W). Activities will include construction camp mobilization and operation, soil and water sampling, and topographical surveying activities to develop information required to finalize design and logistical plans for the full clean-up of the FOX-2 DEW Line Site.

## **PART F: CONDITIONS APPLYING TO THE UNDERTAKING**

Amend Item 6 All sites affected by construction or sampling activities related to the site investigation shall be stabilized, landscaped as necessary, and suitable erosion control measures implemented to minimize sediment deposition into watercourses located on or adjacent to the site, to the satisfaction of an Inspector.

## **PART H: CONDITIONS APPLYING TO ABANDONMENT AND RESTORATION**


Amend Item 1 The Licensee shall submit to the Board, six (6) months prior to the completion of onsite activities, an Abandonment and Reclamation Plan to address contractor demobilization and site remediation operations and will incorporate the following;

- Insert Item 1(i)      The Licensee shall carry out the site investigation work at the FOX-2, DEW Line Site as described in the application dated January 20, 2005.
- Insert Item 1(ii)      The Licensee shall include the monitoring results, along with an interpretation of the results, with the submission of the Abandonment and Restoration Plan for the FOX-2 Distant Early Warning (DEW) Line Site, Longstaff Bluff, Baffin Island, Nunavut, for approval by the Board.

**All terms and conditions of the Licence NWB5LON0308 dated August 5, 2003 still apply.**
