**RE: 1BR-LOR0813 Water Licence Amendment and Renewal Application –
Cape Christian Long Term Monitoring Program**

Dear Ms. Beaulieu:

Please find enclosed a Water Licence Amendment and Renewal Application from Aboriginal Affairs and Northern Development Canada (AANDC) for the Cape Christian Long Term Monitoring Program.

The existing license was issued to conduct remediation works at Cape Christian, a former US Coast Guard Long Range Navigation communication station constructed and operated between 1954 and 1974, located about 16 km northeast of the Hamlet of Clyde River, Nunavut.

The remediation of the site occurred between 2008 and 2011. It involved removal and off-site disposal of hazardous materials, demolition of buildings and structures, excavation of non-hazardous metals and petroleum hydrocarbon contaminated soils, and clean-up of other site debris. All of the non-hazardous wastes were placed in a non-hazardous waste landfill (NHWL) constructed on-site for that purpose. The NHWL was constructed at the site between 2009 and 2010 and was closed in 2010.

In fulfillment of departmental commitments to monitor the landfill post-closure, AANDC initiated a 25-year long term monitoring program at Cape Christian in 2011. Long term monitoring occurred at the site in 2011 and 2013 and a third monitoring event is scheduled to take place in the summer of 2015.



The purpose of this application is to renew and amend the existing water license so long term monitoring can be continued at the site.

Please find enclosed an accompanying CD which includes all documents pertaining to this water license amendment and renewal application. Each attachment has been labeled according to the scheme below:
