## Hi Robert:

This is confirm that these are the main issues that were discussed today during our telephone conversation:

- Remediation activities for Licence No. 1BR-MAC0712 are nearing completion; the site
  is scheduled to close within the coming week or weeks so conditions relevant to
  incineration, which were not included in the terms and conditions of the licence, might
  not be required for this or future phases of the project. Future plans for the site will
  include monitoring; however, regulatory approval will be required first. DCC is
  examining the possibility of submitting an application to the NWB for monitoring in
  2011.
- 2. On the issue of Leachate Tests for incinerator ash affiliated to Licence No. 1BR-FOD0813, DCC indicated that it will discuss with its Scientist an appropriate test from the *Guideline for Industrial Waste Discharge in Nunavut*, a copy of which was provided by the NWB, before making a decision on if a test will be conducted and/or the type of test that will be conducted. DCC was advised that including test results in a request for amendment relevant to this issue could help its case.
- 3. DCC stated that INAC is in the process of preparing its 2010 inspection report for Licence No. 1BR-FOD0813, which may include INAC's recommendations relevant to test parameters at monitoring stations FOD-10 and FOd-11. DCC stated that it will await the inspection report before deciding whether to request changes to sampling terms and conditions in the licence.

If the above-mentioned issues do not accurately reflect what was discussed, please do feel free to add or subtract, from the content.

Hello Phyllis:

I am following up on the Water Use License for CAM-5, Mackar Inlet, granted July 31, 2007. DCC has been diligent in making sure all conditions of the Water Use License are met. As you know, as proponent of the clean up activities, we also apply all the conditions that are identified in the Land Use Permit issued by Indian and Northern Affairs Canada through the NIRB's recommendations.

Therefore, we are requesting clarification of Part E of the Water Use License. Unlike other Water Use Licenses, Part E of the Water Use License does not provide conditions around the use of an incinerator. Nowhere else in the license is incinerator use mentioned either. The Land Use Permit,

however, includes criteria about the use of an incinerator for domestic waste and combustible petroleum products. As for the latter incinerator, section 31(1)(g) of the Land Use Permit states that: The permittee shall dispose of all combustible waste petroleum products by incineration or removal.

Please acknowledge receipt and I look forward to getting the NWB's clarification on this matter.
