Hi Cynthia,

Thank you for providing an update on the status of the Iqaluit project licencing review when we spoke over the phone last week. Based on our conversation, it is my understanding that Transport Canada might receive the NWB licence for this project during the second week of July. It was also my understanding that Transport Canada could commence with the portions of the projects that are not subject to review under this licencing process. In looking at an existing approval that we have for a similar project in Resolute Bay, this could include activities such as staging, aggregate production and access road construction.

As I mentioned last week, Transport Canada's deadline to award the project is July 14th, 2017. If the project is not awarded on or before this date, this important environmental improvement project may not proceed.

Can you please indicate if it is possible to have the licence issued on or before July 14th, 2017 and if our understanding of ability to proceed with some components of the project is correct?

I'm also wondering if you could put me in touch with a contact at INAC with whom I could discuss which components of the project that TC could commence in advance of the NWB licence? Or perhaps TC, NWB, and INAC could have a teleconference this week?
