Aboriginal Affairs and Northern Development Canada (AANDC- formerly INAC) is planning to remediate the former Radio/Weather Station at Nottingham Island located at coordinates ( 63° 06' 43" N, 77° 56' 19" W) which is about 140 Km south of Cape Dorset, Kivalliq Region, Nunavut.

Please accept this as a formal request for written confirmation that the Nottingham Island Remediation Project does not require a land use conformity determination under NLCA Article 11, as it falls within the Kivalliq region, which does not have an approved Land Use Plan. This written confirmation has been requested by the Nunavut Water Board (NWB) as a condition for issuing the water licence for the remediation project.
